Dear Friends, Families and Supporters,

The EastSide Community Learning Center Foundation is pleased to present our Annual Report highlighting the continued pursuit of remarkable outcomes at EastSide Charter School during the 2015-2016 school year.

The year saw significant change at EastSide: A first full year of partnership with Family Foundations Academy in Delaware's first "Network" of charter schools; new leadership on the school and Network levels; a new dedication to fidelity of goals, operations, methodologies, and curriculum; a plan for increased and improved scholastic performance by students as they strive to close the Achievement Gap, and augmented and expanded support for students as they seek to close the Life Gap.

This past year we hosted a visit by Civil Rights icon, Congressman John Lewis, accompanied by Delaware's entire congressional delegation: Senators Tom Carper and Christopher Coons, and Congressman John Carney; we maintained our STAR Level 5 (the highest possible rating) for our Pre-K program; our Summer Enrichment Program, offering fun and quality educational and recreational engagement for our students continued and grew; we instituted a broad and deep After-School Program offering sports, tutoring, and clubs; our athletic programs took off on the wings of Eagles (which we are!) with successes in basketball, cheerleading, and general participation; we added a new Chief Academic Officer to lead our new curriculum; Rachael Mattson became the new school Principal, and Aaron Bass became our new Chief Executive Officer.

Day in and day out our growing cohort of students and dedicated instructors continue to prove that remarkable things happen at EastSide, and that it is possible to achieve high performance in inner city Wilmington.

We are excited for the future and grateful for your support of our mission.



Commitment to eliminating not only the Achievement Gap, but also the <u>Life Gap</u>

Our commitment to educational advancement is a 15% point improvement in those scoring "proficient" in all grades for the coming year. This goal represents a target <u>5 times</u> that of the state average growth (3% per year). After several years of marked academic advancement, those trends reversed in the last two years as measured by the State-mandated SBAC {Smarter Balanced Assessment Consortium] testing regimen (*see*, below).

The trend will change. New curriculum, new leadership, renewed parent involvement as educational partners, and a new dedication to fidelity to goals and processes will lead the way in the rebirth of academic advancement at EastSide .




New leadership at EastSide—our new Chief Executive Officer and Chief Academic Officer [*see*, page 4] and their Team - are committed to challenge the Achievement Gap that exists between urban students and those from more affluent back-grounds. But the EastSide Team also recognizes that our students, though young, must come to envision *and* commit to a <u>Vision Plan</u>—a set of goals and a means to accomplish those goals—which extend beyond their time at EastSide. And so we are dedicated to closing the <u>Life Gap</u>—seen in household income, lifestyle, and societal roles of urban students, even those graduating from college.

We are taking the lead on a new vision for academic involvement in the lives of our students. EastSide is the only Charter in the State of Delaware with a "K-i6+" approach—Kindergarten through College, and beyond. Through what we call **College, then Career**, EastSide aspire to maintain contact and involvement in the educational journeys of our graduates in ensuing years – to and through college. Students will be mentored and supported by EastSide staff—the goal not being simply to attain some level of test scoring, although we are committed to a scoring increase this year and across the board of 15% points, mentioned above. In addition, we are committed to 8th grade graduation, followed by matriculation to a quality high-performing high school, mentoring through high school, support with the college application process, and then additional mentoring through college. After college, we pledge to work with our graduates for two years to aid them in finding a valuable, meaningful job.

See , the chart above which shows the disparities between the lifetime return on investment in college by Whites, Blacks and Latinos after graduating from college.

When our boys and girls become men and women, we want them to have college-based careers and make a positive impact in their communities. Our alumni will be able to achieve their goals based on having had a strong vision of their future selves in their formative years due to strategic feedback, expanded opportunities, and an excellent education.

Exciting New Leadership

Effective July 1, 2016, **Aaron Bass** succeeded Dr. Lamont Browne as Chief Executive Officer of both EastSide Charter School and Family Foundations Academy. Mr. Bass brings extensive educational leadership experience. In 2007, Mr. Bass joined KIPP Philadelphia Charter School as the upper school dean and later, in 2010 founded and led KIPP DuBois Collegiate Academy,

the first KIPP high school in Philadelphia. Highlights of his career to date include:

- In 2004, as Executive Director, founded Breakthrough Fort Lauderdale, part of the National Breakthrough Collaborative, a nonprofit program that served 240 students and prepared middle school and high school students for college, and also gave high school and college students the opportunity to teach. Mr. Bass served as President for National Breakthrough Directors Association, and as Co-Chairman of the Fort Lauderdale Mayor's Educational Board.
- In 2007, Mr. Bass joined KIPP (Knowledge Is Power Program) and was awarded the prestigious Fisher Fellowship, given by the Fisher Family (owners of the GAP, Old Navy) to establish KIPP DuBois Collegiate Academy. KDCA was the only open enrollment school to have an ACT Average in the top 10 HS in Philadelphia. His first graduating class had a college matriculation of 95% compared to Philadelphia's average of 30%. In 2014, he became Chief of Staff and led advocacy efforts for KIPP's expansion in Philadelphia. Under his leadership KIPP was the only school to obtain two new charters in 2014 (adding to KIPP's other 4 schools in the city).
- In 2014 and 2015, Mr. Bass was tapped by the Philadelphia Eagles to be one of their Instructional Consultants. In this role, he provided Professional Development to the Eagles coaching staff and directly supported the Offensive Coordinator, Special Teams Coach, Running Backs Coach, and Inside Linebackers.
- Other highlights: repeat lecturer at UPENN, Temple, Franklin and Marshall College; Served as instructional consultant for the World Bank, Future Leaders of UK, US Dept. of Education, and other community organizations. Also serves on the Alumni Board for Franklin and Marshall College and Black Male Educators Convening.

One of Mr. Bass's key initial steps was the hiring of Stanley Bobowski as EastSide Charter's very first Chief Academic Officer. Mr. Bobowski is a respected and notable educator, with deep experience in curricular development and implementation; having served as both teacher and principal engaged in the challenging task of designing and executing new curriculum and culture, most recently in distinguished service to Mastery Charter Schools in Philadelphia.



Among highlights of his work in resurrecting and energizing scholastic programs are: At Mastery Charter Schools:

- Winner of EPIC Gold Standard Award for academic gains in 2009 and 2008;
- EPIC Silver Standard Award for academic gains in 2010; closed the achievement gap within two years (7th 8th grades);
- In 2011, elevated reading scores on average by 15 points and math by 30 points (3rd 6th grades;
- Closed the achievement gap in math within two years (5th 6th grades);
- Decreased "below basic" rates by 50% within 2 years;
- In five years as a principal, developed numerous leaders to head additional turnaround schools, including 3 principals, 2 network directors, 5 APIs and 3 APSCs;
- 2012-2013 achieved more school metric goals than any other principal in the Network;
- 2014-2015 insight survey results reflected the highest ratings in the Network 9.6 out of 10 in staff satisfaction;
- Teacher retention rates averaging 91%

At Laboratory Charter School Team:

• Recipient of the National Blue Ribbon Award for school success, achieving 100% student proficiency in math and literacy through the entire network.

On March 4, 2016 ESCS students met with Living History ... as Rep. John R. Lewis (D-Ga) visited our school. Adding to the opportunity, Rep. Lewis was accompanied by the entire Delaware congressional delegation, senior Senator, and former Governor, Tom Carper, Senator Chris Coons, and Representative John Carney. In speaking with students, these leaders emphasized the privilege of voting as a means of reaching levels of accomplishment to which all of the students might aspire. Although coming from varied backgrounds, the journeys of these men to the halls of Congress are trails that EastSide students may follow in their lives and careers. Each student in attendance received a copy of Rep. Lewis's book, March, describing his life and times as a tireless champion and a legendary hero of the Civil Rights Movement of the 6o's and 70's. Students were able to interact with all of the Legislators; and to ask questions of them ... a truly unique experience for our students.

School Focus and Highlights

- \Rightarrow Students made over one year of growth on the MAP Assessment.
- ⇒ EastSide features after school activities with transportation for activities like: chess, soccer, basketball, track, volleyball, cheer/ dance, tutoring, and more!
- ⇒ Students in all grades have the opportunity to engage in Social Emotional learning that focuses on their own mental health, social skills, and preparedness for college and life.
- ⇒ EastSide continues to implement the Teaching Excellence Framework, a rigorous teacher evaluation and professional development model, developed at EastSide, and which has been adopted by numerous Delaware Schools better preparing our teachers to provide top level instruction on a daily basis.
- ⇒ EastSide has a Child Study Team that seeks to prevent and support issues surrounding behavior, bullying, suicide prevention, and academics
- \Rightarrow EastSide 7th and 8th graders participated in an outdoor multiovernight camping experience funded, in part, by Cabelas.
- \Rightarrow Target Stores provided significant funding for an 8th grade trip to NYC, and students visited the NY harbor and Ellis Island, Harlem, and the Apollo Theater.
- ⇒ The Ellice and Rosa McDonald Foundation provided significant funding to upgrade all internal lighting at the School ... a boon to classroom work.
- ⇒ The following programs received continued support through supplemental funding provided by generous individuals and the corporate and philanthropic community:
 - Universal free breakfast and lunches
 - Free after-school tutoring
